MEMORANDUM: ALL PARTICIPATING LENDERS

SUBJECT: INTEREST RATE INCREASES

The purpose of this Directive is to inform you of the impending interest rate increases. The interest rate increases outlined below will go into effect today -- Friday, October 10, 2008 at 5:00 p.m. The interest rates for all the Maryland Mortgage Program, Lifeline Refinance Mortgage Program and Homesaver Refinance Mortgage Program products are increasing by 1/2%. The interest rates will be updated on our website and Lender On-Line. This Directive will be uploaded to our website (under Lenders Only/Single Family Housing Directives) and also to Lender On-Line (under Program Documents/Single Family Housing Directives).
